

StrawberryFields MarketPlace Exhibitors June 15-16, 2018



It's time again to prepare for the Cottage Grove Strawberry Fest and we are excited to invite you to participate in this year's StrawberryFields MarketPlace!

We are again bringing together the old BizExpo with the Craft Fair. We will be working with Gingerbread Shows <http://www.gingerbreadshows.com/> to add craft booths to make it more of a shopping destination.

The entire event will still be held at Kingston Park Friday and Saturday, June 15-16, 2018. Participation in the event will give you the opportunity to showcase your business or organization and reach many **more** of the area residents. You'll have the chance to meet many of your existing customers and get your message out to existing and many potentially new clients.

Eligibility

All Strawberry Fest vendors that plan to sell a product must have a valid Minnesota State Tax Identification Number. If you do not have one, one may be applied for by calling Minnesota State Sales Tax and Excise Division at (800) 657-3777 or (651) 296-6181. All vendors must collect and pay sales tax on each taxable sale made at the Strawberry Fest. **A Minnesota form ST-19 must be completed and returned with your application and fee.** It must be completed and returned to us before any sales can be made. The festival reserves the right to review entries and ask a vendor to leave the festival should their behavior be deemed inappropriate by the festival. The Strawberry Fest staff reserves the right to refuse or stop sales or free distribution of products before or during the festival, which it deems inappropriate to the festival.

Vendor Space

The Fest will allot space for each vendor in the designated area of the area that has been deemed appropriate. Payment of the application fee must accompany each application in order to reserve a space. Applicants must supply their own power, electrical cords, tents, tables, chairs, cleanup, safety rope, lighting (if needed) etc. Generators or other portable power supply units need to be stated in this application and may need to be inspected by the State Electrical Inspector. It is the vendor's responsibility to contact the electrical inspector at 651-493-1599, to arrange for an inspection, if required.

When you are filling out your application, please be sure to specify your specific space size requirements. If your set-up runs between sizes, you will need to go with the larger size. Within one week prior to the expo, each registered exhibitor will receive a number along with their assigned space within the mapped area. Remember, if you signed up for a 10x10 space that is the space you will receive. Set-up times will be 2 hours before the fest opens each day. (2-4pm on Friday and from 8-10am on Saturday) There will be individuals available to assist you to your designated area. Location priority will be recorded when the application and check is received.

Under the Big Top

We will be doing the Big Top again this year (a large tent that exhibitors can set up their booth under). It will cost \$1/sqft in addition to the normal booth fee. **i.e.: a 10x10 booth would cost an additional \$100.** If you are interested please check the appropriate box on the application form. We have a max of 12 spaces under one 40x60 tent and need a minimum of 8 exhibitors to do a Big Top tent. If we are not able to put you under the Big Top your Big Top fee will be refunded.

Vendor Hours

Events at the park will run from 4:00pm to 12:00am on Friday, June 15 and from 10:00am to 12:00am Saturday June 16. StrawberryFields MarketPlace will run **Friday and Saturday** from start to SUNSET as there is no direct pre-existing lighting in the StrawberryFields MarketPlace. Vendors can do only one day (Friday or Saturday) but the price is the same. Vendors are expected to stay set up at least until 5:30pm on Friday and Saturday unless otherwise arranged and welcome to stay after dark if you have your own lighting. Booth sizes are 10x10, 20 or 30 and you are responsible for your own shelter and power (if needed – generators are allowed but need to be approved ahead of time to properly assign booth locations).

Charitable and NonProfit Organizations

Charitable and nonprofit organizations may be eligible to receive a discount if they have the proper certifications. A 50% discount will be provided once the application is approved.

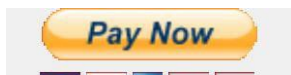
Indemnity
